Deposit and Payment:

A \$500 deposit is required to be placed on the list to purchase a puppy. The order of deposit received will determine the pick order for either a female or male puppy. The \$500 deposit is non-refundable and will be applied to the total purchase price of \$3,000 for the puppy.

Payment in full and signed contract is due at 8 weeks of age.

Deposit Payment: Cash, Venmo or PayPal

Remaining Payment: Due at 8 weeks of age for the puppy
Cash or Cashier's Check

*If puppy is being transported by ground or air, additional fees will apply and be listed in the contract and required to be paid in full before puppy is release from the breeder's care.

Health Guarantee:

First 3 Days

To the best knowledge of the breeder, the puppy is in good health with updated vaccines and deworming treatments. Records of puppy's deworming treatments and

vaccinations are included on pick up date. Puppy is required to visit a licensed veterinarian within 3 days of leaving the breeder's home. If puppy does not visit a licensed veterinarian within 3 days of leaving the breeder's home, the health guarantee is void. The buyer will assume all medical expenses for the puppy after leaving the breeder's home. The health guarantee from the breeder does not cover any kind of injury, hernias, hypoglycemia, giardia, coccidiosis, issues whose cause is unknown or may have environmental links, parasites, viral or oral infections, ingestion of foreign objects, food, or chemicals puppy may have contacted after leaving the breeder's home. If the licensed veterinarian finds the puppy unhealthy due to other reasons or issues than listed, the breeder will issue a full refund to the buyer after the puppy has been returned to the breeder's home at the buyer's expense and the breeder has the puppy examined by a licensed veterinarian of the breeder's choice and at the breeder's expense. The breeder must receive a copy within 24 hours of the licensed veterinarian's exam results containing the clinic's letterhead with the veterinarian's signature and date. Exam documents will be emailed to longbranchgoldens@gmail.com. Puppy must be returned to the breeder's home within 72 hours of receiving the buyer's veterinarian's exam report.

1 Year Health Guarantee

For up to 1 year of age, if the puppy is deemed to have a terminal genetic health defect which will take the puppy's life, as determined by a licensed veterinarian, the breeder will issue reimbursement for veterinarian expenses up to the purchase price of the puppy, with the buyer retaining ownership of the puppy. The breeder must receive a copy within 24 hours of the licensed veterinarian's exam results containing the clinic's letterhead with the veterinarian's signature and date. Exam documents will be emailed to longbranchgoldens@gmail.com. The breeder has the right to choose a licensed veterinarian of the breeder's choice to have the puppy examined before reimbursement is issued.

2 Year Health Guarantee

For up to 2 years of age, the breeder guarantees against severe hip dysplasia in the purchased puppy. The hip rating of the puppy will be determined by only the Orthopedic Foundation for Animals (OFA) or Penn Hip. The puppy must be sedated for submitted radiographs. Expenses for radiographs and hip rating is the buyer's expense. If the puppy is determined to have severe hip dysplasia, the breeder reserves the right to have radiographs retaken and resubmitted at the breeder's expense. If the puppy is determined to have severe hip dysplasia after the second reading, the buyer has the option to be reimbursed half of the purchase price and return the puppy at the buyer's expense to the breeder or to be placed on the waitlist for the next litter for a puppy costing half the original purchase price. If the puppy has signs of being physically abused or injured, in an unhealthy condition or overweight as determined by a licensed veterinarian of the breeder's choice, the health guarantee is void.

Spay/Neuter

Buyers will provide documentation from their licensed veterinarian of their puppy being spayed/neutered to longbranchgoldens@gmail.com. If documentation is not sent by 18 months of age, all health guarantees are void. Puppy will be registered with the AKC with limited registration only.

Females: Spayed by 18 months age
Males: Neutered by 18 months of age

Health Guarantee Continued

All health guarantees are non-transferrable and will become void if puppy is sold or rehomed. All health guarantees will become void if puppy has been physically injured, abused or unhealthy as determined by the breeder's choice of licensed veterinarian and puppy will be then returned to the breeder. All health guarantees will be void if puppy has not been on flea and tick preventative treatment and heartworm preventative treatment, the buyer will need documentation for proof of purchase of these treatments. All health guarantees will be void if puppy has not been kept current on all vaccinations with documentation from a licensed veterinarian. Breeder makes no guarantees regarding the loss of the puppy due to accidental death, theft, or loss beyond the control of the breeder.

First Right of Recovery

In the event the buyer is unable or no longer wants to care for the puppy purchased, Ben and Kristine Ideus retain the rights to purchase the puppy back from the original buyer first, for the amount of the deposit. The buyer will never sell the puppy to a pet store, broker, puppy mill, surrender to a shelter, or give puppy up for purchase to another buyer.

Shipping/Ground Transportation

Shipping:

The buyer has the option of shipping the puppy through American Airlines Cargo Pet Embark to their desired location in the United States. The puppy will leave from the Eppley Airfield in Omaha, Nebraska (OMA) or Kansas City Airport in Kansas City, Missouri (MCI). The buyer will assume all cost associated with the flight including and not limited to the puppy's pre-travel veterinarian examination, crate with clip-on water and food dish, absorbent pad, and flight ticket for puppy. Please contact us for a quote on the cost of your puppy flying to your desired location within the United States.

Ground:

The buyer has the option of meeting the breeder in a preset location to pick up their puppy. The buyer will assume all cost associated with ground transportation. Please contact us for a quote on the cost of your puppy having ground transportation.
